- Explained the post-socialist systemic transformation in the Republic of Moldova through the history of a social group called “intellectuals”, so defined by their graduate degree and by the non-manual nature of their work.
- Used as the main analytical tool of the process of social change the bourdieusian concept of social capital.
- Used as an economic reading grid of the change the Regulation Theory and Institutional Economics.
